- 1. **Guardianship:** I confirm that I am 18 or over and the legal guardian of the child(ren) registered to participate in the Colour Run on 6th July 2024
- 2. **Safety Rules:** I agree that my child will participate in the Colour Run Challenge in accordance with the specific safety rules clearly explained by volunteers at the beginning of the Colour Run.
- 3. **Colour:** I understand that participating in the Colour Run is a potentially hazardous activity where the coloured powder will be thrown at and around my child during the event. However, I understand that the powder is not harmful to people, animals or plant life.
- 4. **Risk of Injury**: I understand that participation in the event involves inherent risks, including but not limited to physical injury, cuts, scrapes, bruises, sprains, strains, dehydration, and heat exhaustion. I acknowledge that these risks are greater than those encountered in everyday life.
- 5. **Health and Safety:** Participants are required to follow all safety rules and instructions provided by event volunteers, including the wearing of protective eyewear (sunglasses or goggles) as mandated by the event's safety guidelines. All participants must behave appropriately, respecting fellow participants, volunteers, staff, and property.
